About Us

Clothed by Faith is a 501(c)3 non-profit organization whose mission is to demonstrate God's love by the provision of gently used clothing to those in need. This is who we are in the words of our Founder, Abi Fourie:

'I founded Clothed by Faith (CBF) with a simple purpose – to show god's love by providing clothing to children at risk and living in poverty.

In July 2013 I felt led by the Lord to reach out to people struggling with poverty right here in Katy, Texas. It was hard to believe that even in affluent areas, poverty existed. After some research, it was a shock to discover how big an issue poverty is right here on my own doorstep.

At CBF our mission is to seek out those who need us most and provide them with new or gently used clothing. We do this through responding to individual requests and by partnering with other charitable organizations.

Most of the clothes we give away are gently used, having been donated by the public but undergarments and socks are always supplied new. We need your help to sustain what we have started and to reach out and help those that desperately need support. Thank you for helping us."

1. Learn about Clothed by Faith

Understand who we are, where we are located, who we serve and what our ministry is all about. What kind of clothing do we need at the time of your fundraiser? Can you help us with this need either through raising money or organizing a clothing drive or both? Please take the time to visit our website and find out the answers to these questions and please take the time to call us so we can help guide you through the process and let you know what our greatest needs are at the present time.

2. Assemble your Team

For certain kinds of fundraisers, it is helpful to put some thought into building a team that has a blend of relevant and diverse skills and even useful connections. In order to achieve this, you might need to spread the net wide by considering everyone you know, including your friends, family, colleagues, neighbors, and anyone else you feel comfortable reaching out to be on the team. Choose a team captain to keep the team on task and to help create your fundraising plan and implementation strategy.

3. Plan your Fundraiser

Large scale fundraisers can be time-consuming and expensive, and it is important to take this into consideration when planning your event. Careful planning helps to identify what some of these challenges are and manage them in such a way as to optimize the success of your fundraiser. Suggestions for your Fundraising Plan are provided in the next section.

When organizing a **large or complex fundraiser** such as a gala, sporting event or holiday market, it is helpful to consider the following aspects of the overall fundraising plan. These are suggested topics only and are by no means an exhaustive or mandatory list.

When organizing a **simple fundraiser** that does not involve managing large numbers of guests, participants, third party vendors and public spaces it is not necessary to create a detailed plan. However, it is still a good idea to give thought to some aspects such as your fundraising goal, target audience, how you will publicize the event and how it will be set up on the day.

Fundraising Goal: Set a fundraising goal taking into account input from the event committee and organization staff and make sure everything in the plan is geared towards meeting this objective. The fundraising goal is the net amount raised after expenses have been paid

Budget: A complete budget should be created listing all expenses such as staff, invitations, social media and other social media, space rental, catering, entertainment, transportation, security, utilities, insurance and other outgoings specific to your event. Provision should be made for unforeseen expenses (contingency)

Leadership and Sponsorship: The leadership team is a host committee generally comprissing business leaders, team leaders, key donors and even local celebrities. These people are responsible for contributing time and effort to the event and encouraging others to do the same. Sponsors often provide a significant income and will use your fundraising event to publicize their organization and its charitable interest.

Target Audience: Determine your target audience – is this a fundraiser to which the general public is invited or is it geared towards a specific group of businesspeople, parents, professionals or employees? Tailor your promotional activity accordingly.

Timetable and Event Setup: Build a documented project plan as well as a timeline of events leading up to and on the day itself. The plan should divide up the areas of responsibility and allocate ownership of each to a specified individual. Due dates for deliverables should be clearly defined and progress tracked at regular meetings. Resources for the day of the event need to be identified and volunteers assigned clear tasks. Where will your fundraiser take place, will food be served, will there be entertainment, what attire is required (if any), who will take care of clean-up afterwards?

Publicity: Convince your supporters that your fundraiser is worthy of their time and attention and keep reminding them at various points leading up to the day of the event. There are numerous channels of available communication: email, website, social media, mailed invitations, phone banks, local media outlets

Sales: Establish a procedure for selling tickets (if it is a ticketed event) and accepting donations. Provide more than one way in which supporters can make a donation and define donation levels and any associated perks



Dry Run: For large, complex events such as sports events and holiday markets where people need to understand the flow of activity and the layout of the fundraiser on the day, a practice run-through is helpful

Thanks: It is very important to acknowledge and thank your donors, sponsor, vendors, contributors and volunteers. Not only is this courteous but it will motivate them to take part in any future fundraisers you may organize



Simple Fundraising Ideas

- 1. **Baby and/or Kids Res**ale host a baby and kids' clothing resale
- 2. Bingo get prizes donated and charge an entrance fee for a night of bingo
- 3. Party get entertainment and food donated and charge a ticket fee for each guest
- 4. **Spelling Bee** hold a spellathon with contestants collecting donations for the number of words spelled correctly. Top winners receive donated prizes
- 5. Smoothie Stand variation on a theme of lemonade stand
- 6. Strike Gold ask participants to donate old gold jewelry and convert it to cash
- 7. 50/50 Raffle sell raffle tickets and offer half of the proceeds as prizes
- 8. **Buy a Meal** volunteers donate homemade meals to sell
- 9. **Karaoke** participants raise pledges to lip-sync and charge entry
- 10. **Car Wash** groups wash cars in a high traffic location for donations
- 11. **Gift Wrap** offer gift wrap services for a donation
- 12. **Egg Hunt** provide egg hunt using egg donations for a fee
- 13. Bake Sale bake or collect donated baked goods and sell at a large event
- 14. **Bracelets** sell silicone bracelets to promote Clothed by Faith
- 15. **Scratch Cards** donors receive a sheet of coupons for a small donation
- 16. Flamingos receive donations to deliver fake flamingos to a person's yard
- 17. **Text it** use a service that allows Clothed by Faith to receive donations by text
- 18. **Sit-a-thon** offer babysitting services for a designated evening or two
- 19. Coin Collection collect change for change? And make it into a competition
- 20. Holiday Shop collect new and gently used holiday items and resell in gift baskets
- 21. **Dress Down** allow workers to dress down for the day by making a donation
- 22. Cookbook group members offer their best family recipes for a cooker book
- 23. **T-Shirts** design and sell t-shirts advertising Clothed by Faith and its cause
- 24. Eat for a Cause organize a spirit night for Clothed by Faith at a local restaurant
- 25. Matching Gift ask a corporation or individual to match your donation
- 26. Birthday Pledge ask for donations to Clothed by Faith in lieu of gifts
- 27. **Talent Show** compete for a fee and sell tickets to come and watch
- 28. Garage Sale ask for donated items to raise money in a garage sale
- 29. **Sponsored Run** designate Clothed by Faith as beneficiary for your run
- 30. Class Action offer tutoring or classes in a skill you have and donate the proceeds

Corporate Matching Gift Program

Directions for Corporate Matching Gift Program:

- 1. Contact your HR department and ask if your employer has a matching gift program
- 2. If so, ask for a matching gift program form to complete (or visit the applicable website) and submit a copy to your employer and to Clothed by Faith. Print a copy for your records.
- 3. If your company does not have a corporate matching gift program but is interested in making a matching gift, please provide them with the following information:
